SUBJECT: 2021-2022 School Readiness Wait List Appropriation 2021-015

The Division of Early Learning (DEL) was provided a \$72 million dollar allocation in Specific Appropriation 83 of Chapter 2021-036, Laws of Florida, to expand school readiness services to families currently on the school readiness waiting list. To be eligible for this funding, an early learning coalition (ELC) must have children on its Waiting List as of July 1, 2021, that complies with Rule 6M-4.300, Florida Administrative Code (F.A.C). This proviso allocation requires the Division of Early Learning to work with each ELC to verify the number of children on its wait list.

The purpose of this memo is to provide instructions for all ELCs and RCMA to review and verify the number of children on the School Readiness Waiting List as of July 1, 2021. The School Readiness Waiting List with data from EFS Modernization with data as of June 30, 2021, reflects the number of children by coalition on the waiting list on the morning of July 1 as 10,740 children.

The 2020-21 School Readiness Waiting List Details Report is located at: https://oel-reports.floridaearlylearning.com/#/workbooks/3313/views. Each ELC can view its coalition and county-level reports, and a detailed child listing that corresponds to the monthly numbers from the last day of the month.

The 'Monthly Waiting List Details' tab is shown in yellow below. Note that DEL staff can see all detailed child data but ELCs can only see their children. County is a report option, along with the period to report. To facilitate the review and verification, this report can be exported to Excel.



ELCs are instructed to review the waiting list file to verify the number of children on the waiting list, and either confirm the total number of children or provide documentation to support any discrepancies within fourteen (14) calendar days and notify Bob Pope, Bob.Pope@oel.myflorida.com. Along with this verification, DEL asks that ELCs communicate any limitation to the number of children the ELC will be able to place into care due to child care capacity issues within the ELC's service area. DEL will coordinate with ELCs as needed in order to complete review and verify data.
