### New Fiscal Year Ushers in Change

New early learning legislation takes effect.

Much of OEL's June activity involved preparing to implement House Bill 7165, which takes effect July 1. Working groups with representatives from OEL, coalitions and other entities involved in early learning services convened in person and by phone to consider how to move the bill from words on a page into reality around the state. As of July 1, there are 30 early learning coalitions in Florida following the merger of the ELC of Putnam & St. Johns Counties with the ELC of Clay, Nassau, Baker and Bradford Counties. The combined early learning coalition is the ELC of North Florida.

Attendees discussed the impact of the new legislation on coalitions. Several committees were appointed to consider various aspects of the new bill.
